## Import Permit Service for Research Materials

May 2026

# About the Service

- This service enables research entities to obtain permits for importing chemical materials used in research, development, and innovation, pursuant to **Supreme Order No. 41772** dated 22/5/1447H, corresponding to 13/11/2025G, which **authorizes the Research, Development and Innovation Authority (RDIA) to issue permits for the import, export, re-export, and clearance of chemical materials** required by research entities, in accordance with the RDIA's mandate set out in its organizational arrangements.

## Target Groups for the Service:

Universities, research centers, and companies importing on behalf of research entities.

# Procedures for Importing Research Materials via the Saudi Minds Platform

## Service Requirements:

- Import must be for **scientific research purposes** only (**Research Use Only**).
- Submit an "Import Permit" request on the Saudi Minds platform and complete the electronic form with clear and accurate information about the materials to be imported.
- When completing the electronic form, please ensure the following documents are attached:
  1. Invoice or quotation specifying the CAS number or UN number for each required material.
  2. Copy of a valid commercial registration or industrial license (if the applicant is a company).
- The requested materials must not be classified as restricted (hazardous materials or those used in the manufacture of explosives or narcotics) as per the Chemical Materials Management System. If restricted materials must be imported, the following additional documents are required:
- A valid Civil Defense license confirming that chemical storage facilities meet fire prevention and protection requirements and are under preventive supervision, or evidence of Civil Defense approval for government entities.
- Forms and undertakings required by the High Commission for Industrial Security.

# Platform Registration Steps for the Importer

1. Create an account on the Saudi Minds platform ([saudiminds.rdia.gov.sa](https://saudiminds.rdia.gov.sa)) using your work email (not your personal email).
2. After creating the account, please send an email to [rdi\\_materials@rdia.gov.sa](mailto:rdi_materials@rdia.gov.sa) and request to have an "Importer" privilege on the Saudi Minds platform.
3. Once you get the "Importer" privilege, you can then start using the service by logging into the platform, selecting "Import Permit Management", and then choosing "Add New Request".

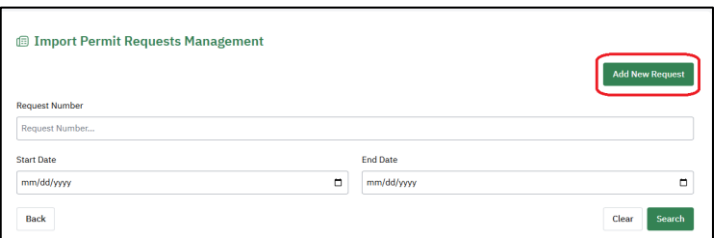
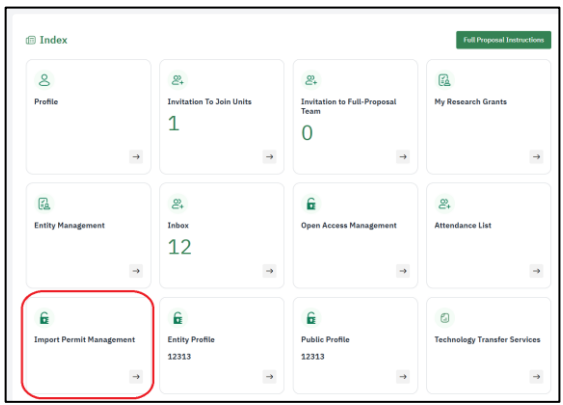

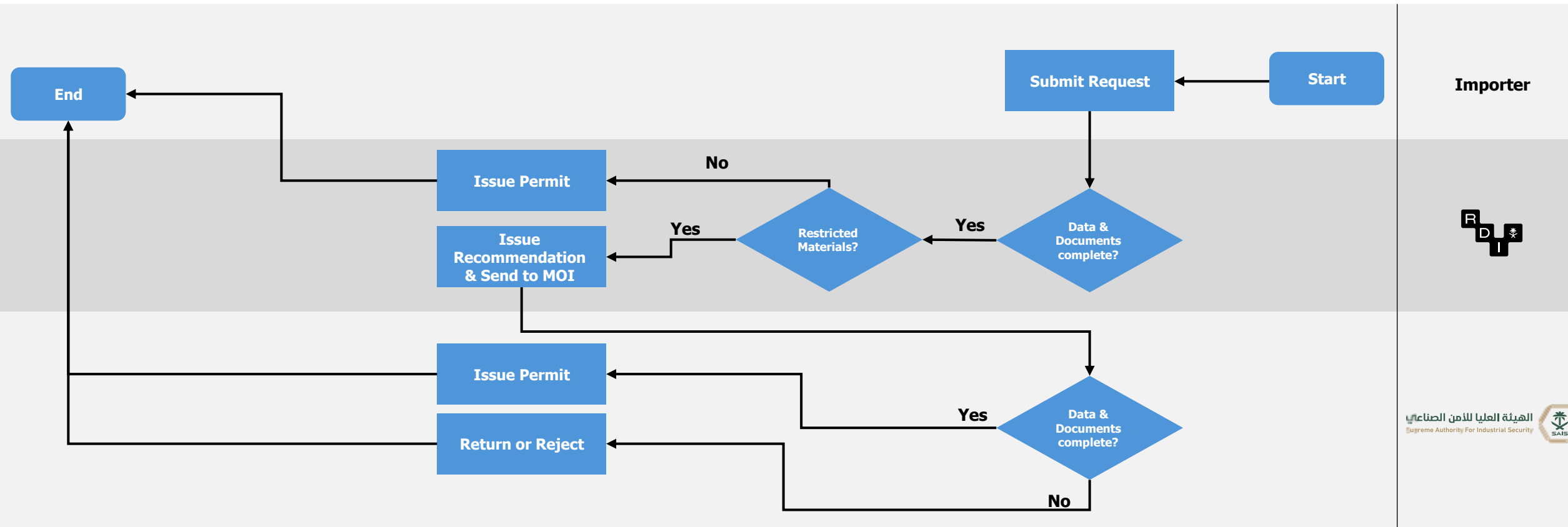

# Import Procedure Details



**Important:** After obtaining the import permit, the importer should create a clearance request on the "Fasah" platform, and must attach all the required documents, including the "Import Permit Certificate".

\*Materials from lists 1, 2, 3 of the Chemical Materials Law

## Notes:

- **SLA:** Five business days from the arrival of the request to the RDIA team, provided that the request includes all required data and attachments.
- After receiving the import permit certificate, the applicant must begin clearance procedures early to avoid material being held at the customs port. Clearance requests can be submitted via the Zakat, Tax and Customs Authority website, with the import permit certificate attached.

- The importer assumes all liability for damages resulting from misuse of these materials or use for purposes other than those for which they were imported.
